The candidate is required to come prepared to stay for more than four days for DV/Medical examination at his own cost. Candidate have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where the investigation like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/hospital.
- **6.0** The candidature of the shortlisted candidate is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/ deficiency/ discrepancy detected in the information furnished by him in his online application or any malpractice on his part coming to the notice at any stage of the recruitment process or thereafter.

- **2.** Candidates are advised to upload their educational, caste and other required certificates / documents in RRB Document Verification portal https://oirms-ir.gov.in/rrbdv, only in the prescribed format given in the CEN, otherwise their candidature will be withheld and they will not be eligible for medical exam till they produce correct documents.
- **3.** Block date for verification of original documents for absentee candidates is **15.09.2025**. It must be noted that failure to report for the Document Verification on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. No fresh e-call letter will be issued.
