



Schedule For Document Verification of Various posts of JE, DMS, CMA, CS & MS Under CEN 03/2024

1.0 The list of 483 candidates provisionally shortlisted for the Document Verification (DV) & Medical Examination was published in the official website of RRB, Bhopal on 21.07.2025.

2.0 Further to the above, these 483 Candidates with the Roll Numbers given below are called for Verification of Documents / Certificates & genuineness of candidature and Medical Examination as scheduled below. Candidates are advised to report to Railway Recruitment Board, Bhopal East Railway Colony [Near Bhopal Railway Station] Bhopal - 462010, as per scheduled date and time mentioned below.

3.0 SMS/E-mail alerts are being sent to candidates' registered mobile / email ID for downloading their e-call letter from RRB's website.

4.0 The candidates called for DV should produce all the original documents along with two sets of photo-copies in A4 size as detailed in the CEN and e call letter issued for Document Verification.

5.0 Those candidates who will be called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital (Bhopal, Jabalpur & Kota) located in the jurisdiction of concerned RRB on the next day of the DV. The candidates are required to come and prepared to stay for more than four days for DV/Medical examination at their own cost. Candidates have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where the investigation like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/hospital.

6.0 The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/ deficiency/ discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.

7.0 It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.

8.0 While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.

16.0 IMPORTANT INSTRUCTIONS

1. Candidates are advised to upload colour scanned copy of their recent passport size photograph (preferably in light-coloured clothes and against light background) and signature in RRB Document Verification portal <https://oirms-ir.gov.in/rrbdv/> following the instructions mentioned therein. This portal will be active for uploading from 01.08.2025 and closes on the block date of DV.

2. Candidates are advised to upload their educational, caste and other required certificates / documents in RRB Document Verification portal <https://oirms-ir.gov.in/rrbdv/> , only in the prescribed format given in the CEN, otherwise their candidature will be withheld and they will not be eligible for medical exam till they produce correct documents.

3. As mentioned in the CEN-03/2024 under General Instructions at the para 1.12 (b), the shortlisted candidates must exercise his/her options for merged categories posts into a common category as given in the Annexure -A (I) in the CEN. If no option is exercised by the shortlisted candidates before DV, it will be presumed that the candidate has no specific choices to make on merged categories of posts and allotment will be made as per the availability and merit.

Hence, Candidates are advised to exercise of such option on the link <https://www.rrbapply.gov.in/>

After logging in, the candidates can exercise the options on merged categories duly filling their registration number for the CEN -03/2024 (JEs) as per instructions given in the attached annexure.

4. Block date for verification of original documents for absentee candidates: 22.09.2025. It must be noted that failure to report for the Document Verification on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. No fresh e-call letter will be issued.
