3. The above Candidates have the option to make an appeal to the Principal Chief Medical Director (PCMD), West Central Railway, Jabalpur against the Railway Medical Authority who conducted the medical examination through the RRB Bhopal
4. Candidates have to fill the Proforma 'A' and Proforma 'B' as attached and send to the Chairman, Railway Recruitment Board, East Railway Colony (Near Railway Station Bhopal), Bhopal Madhya Pradesh Pin Code-462010, before 18.00 hours of 14/02/2026 through the Registered/Speed Post only.

Procedure for Appeal

The appeal will be entertained only if: -

1. The candidate produces a certificate in the attached prescribed format (Proforma 'A') from a Government/Private Doctor of the specialty/specialties in which the candidate has been found unfit.
2. The certificate should contain a note that the Government / Private Specialist is fully aware of the physical and visual standards set by the Indian Railways for the particular Medical Category. He should also aware with the fact that the candidate has already been declared unfit in the concern Medical Category by the Appropriate Medical Board.
3. The certificate should bear the photograph and mark of identification of the candidates, duly attested By the Medical Certificate Issuing Authority, the Government/Private Doctor, duly mentioning its MCI/State Registration Number.
4. Candidate will be required to pay Rs.1000/- (Rupees One Thousand only) through the Demand Draft payable in favor of Chairman / RRB/ Bhopal .
5. If PCMD, West Central Railway has the opinion of re-examination of the case of appeal, he may nominate a Medical Board to re-examine the candidate. The decision of the PCMD, West Central Railway will be communicated to the candidates through the RRB/Bhopal.
6. If, the decision changes from unfit to fit in required category, the amount of Rs.1000/- submitted through DD will be refunded to the candidate. In all other cases, the DD amount will be forfeited and the candidates will not have any claim on the same.
7. After this appeal no further chance will be given to the candidates for medical examination.

NOTE:

- 1) Appeal against the medical fitness should be sent in his / her own handwriting with signature.
- 2) The proforma 'A' should contain detail diagnose particulars (both with glasses and without glasses for visual standards).
- 3) The appeal will be entertained only with the appeal letter as given at Proforma B, Original Medical Certificate as given as Proforma A & DD for Rs.1000/- in favor of Chairman RRB Bhopal
